- 1. Call to Order:** Chairman Orellana called the meeting to order at 5:30 PM. The Invocation and Pledge was led by Linda Bricker.
- 2. Roll Call:** 47 Present, 13 by Proxy, Total 60, Majority 31.
- 3. Chairman's Welcome:** Chairman Orellana welcomed the Committee members.
- 4. Adoption of Agenda:** 1st: Amity Kissack (4-1) 2nd: Vicki Swenson (1-5). Passed by voice vote.
- 5. Guest Presentation:** Campbell County 250 Committee
- 6. Approval of Minutes:** 1st: Patricia Collins (1-15) 2nd: Bill Brown (1-24) to approve the minutes for the September 25, 2025 meeting. Passed by voice vote.
- 7. Report from Chairman:** Chairman Orellana reported that Caucus will be held on February 7, 2026 at Cam-plex Central Pavillion at 1:00 PM. Checking account balance as of Dec. 4, 2025 is \$9,951.15.
