The precinct caucus chairman may run the meeting as formally or informally as desired. It is recommended that an informal approach is used to help those that aren't familiar with Roberts Rules to participate in the caucus.

The Party officers are there to help you run your caucus. If you have any questions, grab them from their caucus to help resolve any difficulties or answer any questions.

SPECIFICS and CONDUCT OF PRECINCT CAUCUSES

(Excerpts from County Bylaws - Article IV County Convention, Certified 2024.)

1. MEMBERSHIP

- a. Delegates to the County Convention shall be the members of the County Central Committee and those chosen by the caucuses of the several precincts within Campbell County. All County Convention Delegates and Alternates shall be at the time of the call for the Convention be residents of the precinct they represent and registered Republicans.**
- b. Each Precinct Caucus may also choose alternate Delegates equal in number to its allotted delegates and shall designate the priority in which the Alternates shall replace absent Delegates.**
- c. If Precinct Committeeman or Precinct Committeewoman vacancies exist at the time of the Caucus, the Caucus may elect Delegates equal in number to the vacancies.**

2. PRECINCT CAUCUS

- a. Precinct Caucuses shall be held not more than twenty-five (25) days nor less than ten (10) days prior to the County Convention or as provided by these County Bylaws.**
- b. The County Chairman shall issue the call for the Precinct Caucuses by publishing a notice of the number of Delegates to be selected from each precinct, the date, time, and place for each caucus in a newspaper(s) of general circulation in Campbell County not less than ten (10) days prior to the Precinct Caucuses.**
- c. Several Precinct Caucuses may be held in a single location. In any year that it is practicable, the County Party shall hold an All-Precinct Caucus at a central location in Campbell County. All Republicans who have registered within the precinct at the dates of the call of the Precinct Caucus shall be entitled to participate and vote at the Precinct Caucus.**
- d. Proof of such residence and registration shall be by the County Clerk's voter list as of the date of the call of the Precinct Caucus.**
- e. **Proxy votes will not be allowed at the precinct caucuses.****

3. APPORTIONMENT OF PRECINCT DELEGATES TO THE COUNTY CONVENTION

- a. These County Bylaws may designate the total number of Delegates to be elected to the County Convention. If they do not designate the total number of Delegates to be elected to the County Convention, the County Executive Committee is authorized to designate that number.
- b. The Delegates to which each precinct shall be entitled at the County Convention shall be determined, as nearly as possible, in proportion to the total votes cast in each precinct for the Republican candidate for the office of U.S. House of Representatives at the preceding general election.
- c. Each precinct shall be entitled to at least two (2) Delegates in addition to its Precinct Committeemen and Precinct Committeewomen.

4. CONDUCT OF PRECINCT CAUCUSES

- a. Either a Precinct Committeeman or Precinct Committeewoman in attendance at the Precinct Caucus shall be elected Caucus Chairman. In the event of an All-Precinct Caucus, the County Chairman or his designee shall preside.
- b. In the event there is neither a Precinct Committeeman nor a Precinct Committeewoman in attendance, those assembled and qualified to vote shall elect from among them a person to serve as Caucus Chairman.
- c. The Chairman shall take nominations of qualified Republicans residing within the precinct to be Delegates or Alternates to the County Convention and shall call for any Resolutions, Platform planks and County or State Bylaw changes to come before the caucus.
- d. The election of Delegates and Alternates shall be by secret ballot, if desired by anyone in attendance at the Precinct Caucus.

The Caucus Chairman shall, within the next five (5) days, certify in writing to the County Chairman the names of those elected Delegates and Alternates to the County Convention from that precinct, and all Resolutions, Platform planks and County or State Bylaw changes proposed by the Precinct Caucus.

PRECINCT CAUCUS ATTENDANCE REPORT

PRECINCT CAUCUS CHAIR(S): Either the Precinct Committeeman or Committeewoman in attendance shall be elected Chairman of the Precinct Caucus. In the event there is neither a Precinct Committeeman or Committeewoman in attendance at the Precinct Caucus, then those assembled and qualified to vote shall elect a person who shall serve as Precinct Caucus Chairman.

THOSE QUALIFIED TO VOTE: All Republicans who have registered within the precinct on or before the date of the call of the Precinct Caucus – **January 24, 2026** – shall be entitled to participate and vote at the Precinct Caucus. Proof of such residence and registration shall be by the County Clerk’s registered Republican voter list as of January 26, 2026. NO proxies will be allowed in the Precinct Caucus, County Convention, or State Convention.

HOW TO WRITE A RESOLUTION

The form in which a resolution is presented is important and a standard form is prescribed. The State Convention will issue a booklet containing all those approved by the Convention. It is important that they adhere to a similar style. If a resolution does not follow the particular style defined here the Resolutions Committee may reject it. Don't expect the Resolutions Committee to rework your resolution. They don't have much time, and you may not like the results.

Resolutions take a standard form starting with the justifications for the resolutions, followed by the resolution itself and concluding, if necessary with the actions required by the resolutions. The justifications and the action sections are optional.

REFERRING to the 'PARTY'

When writing a resolution, the resolutions being drafted are specific to the organization making the resolutions. When writing a resolution for a county convention, all resolutions apply to the county party, at the state level the resolutions will apply to the state party. It is typical for the party to refer to itself many times in the drafting of resolutions. Drafters should make it clear which party is taking the action or beliefs. The style for the state GOP is to refer to "the Wyoming Republican Party". The style for the Campbell County GOP is to refer to "the Campbell County Republican Party".

JUSTIFICATIONS

The justification section provides detail on the topic of the resolution. This section is optional and may be forgone if necessary. It should be included if the topic of the resolution relies on specific detail that is needed for the resolution to be fully understood. If possible, the justification section should refer to at least one of the Platform core principles.

Each additional justification adds detail by fleshing out the topic of the resolution. Each justification should be tied to a platform core belief or a verifiable fact. Each justification starts with a 'WHEREAS'. If another justification follows the current justification it must end with ', and'. If it is the last justification before the declaration of the resolution it ends with just a comma, ','.

Example:

WHEREAS the Wyoming sage grouse core areas infringe on private property rights, and

WHEREAS the BLM proposed to remove 15 million acres of public land in central Wyoming for sage grouse protection,

RESOLVED CLAUSES

This is the meat of the resolution. It should clearly state the position the Party should take regarding the issue.

It always follows the phrase 'THEREFORE BE IT RESOLVED'. If a resolution has no justification (WHEREAS) clauses, drop the 'THEREFORE' and the resolution should begin by stating 'BE IT RESOLVED'.

A resolved clause should be a single thought and avoid any compound sentences. A useful rule of thumb is if the resolution contains the words 'and' to join two sentences then it should be broken up by beginning with 'BE IT FURTHER RESOLVED'.

For example, this:

THEREFORE, BE IT RESOLVED the Wyoming Republican Party supports the right of institutions, businesses, and individuals to refuse services that are inconsistent with their religious tenets and that would infringe upon their freedom of conscience of religious expression as stated in the First Amendment and we believe it is our duty to protect that right by ensuring that no one is forced by the government to violate their conscience and deeply held religious beliefs.

Is better written as:

THEREFORE, BE IT RESOLVED the Wyoming Republican Party supports the right of institutions, businesses, and individuals to refuse services that are inconsistent with their religious tenets and that would infringe upon their freedom of conscience of religious expression as stated in the First Amendment.

BE IT FURTHER RESOLVED it is the Party's duty to protect that right by ensuring that no one is forced by the government to violate their conscience and deeply held religious beliefs.

ACTIONS

Specifying action for a resolution is optional.

Actions specified can be a variety of things. Common actions are, calling for legislators to work for or against a particular bill or idea; asking the party chair to communicate the resolution to a specific party, such as the Wyoming Congressional delegation, or even call upon the party to take a specific action, such as form a committee, or draft model legislation.

Examples:

BE IT FURTHER RESOLVED that the Party requests that the Campbell County legislators oppose the imposition of a gross receipts tax; and

BE IT FURTHER RESOLVED that the Secretary shall transmit a copy of this resolution to those Campbell County legislators and the Joint Interim Revenue Committee of the Wyoming Legislature to make known to them the sentiment of the Party; and

BE IT FURTHER RESOLVED that the Chairman of the Party propose for adoption by the Wyoming Republican Party State Central Committee a resolution opposing the establishment of a gross receipts tax.

RESOLUTION EXAMPLES

Resolution declaring a principle

WHEREAS our Founding Fathers believed that the government that governs least, governs best and the size and authority of the present Federal Government must far exceed what they ever could have imagined,

THEREFORE, BE IT RESOLVED the Party believes the federal government should be reduced in size by increasing efficiency by reducing multiple agency overlap, and returning the function of government to within the scope of constitutional enumerated powers.

Resolution without justification or actions

BE IT RESOLVED the Wyoming Republican Party encourages state and local government agencies to use Wyoming resources before contracting out-of-state or out-of-country resources.

Resolution adopted outside of convention calling for specific actions

WHEREAS Wyoming is in the midst of an economic downturn due to its reliance on mineral extraction, in particular coal; and

WHEREAS the Interim Revenue Committee of the Wyoming Legislature has now voted 11-3 in favor of the imposition of a gross receipts tax on businesses in Wyoming; and

WHEREAS tax increases are inimical to economic recovery and job growth; and

WHEREAS a gross receipts tax is akin to a business income tax inherently inequitable to businesses, is passed on to consumers, is regressive and, like all taxes, will not be repealed regardless of need; and

NOW THEREFORE BE IT RESOLVED that the Campbell County Republican Party opposes the imposition of a gross receipts tax; and

BE IT FURTHER RESOLVED that the Campbell County Republican Party requests that the Campbell County legislators oppose the imposition of a gross receipts tax; and

BE IT FURTHER RESOLVED that a copy of this resolution be immediately provided to those Campbell County legislators and the Joint Interim Revenue Committee of the Wyoming Legislature to make known to them the sentiment of the Campbell County Republican Party; and

BE IT FURTHER RESOLVED that the Chairman of the Campbell County Republican Central Committee propose for adoption by the Wyoming Republican Party State Central Committee a resolution opposing the establishment of a gross receipts tax.

RESOLUTION TEMPLATE

WRITE LEGIBLY: IF YOUR RESOLUTION IS NOT READABLE IT WILL BE DISCARDED!

Add justifications for the resolution after each 'WHEREAS', avoid compound justifications. Use one WHEREAS per justification. Use the back of the form to add more WHEREAS clauses. Declare the resolution after the 'THEREFORE BE RESOLVED'.

A resolved clause should be a single thought and avoid any compound sentences. A useful rule of thumb is if the resolution contains the words 'and' to join two sentences then it should be broken up by using a 'BE IT FURTHER RESOLVED'.

Add actions, if necessary after additional 'BE IT FURTHER RESOLVED'. Common actions are, calling for legislators to work for or against a particular bill or idea; asking the party chair to communicate the resolution to a specific party, such as the Wyoming Congressional delegation

Use the back of the form to add more 'BE IT FURTHER RESOLVED' clauses. Make sure to add 'SEE BACK FOR MORE' if the back contains additional content.

CHANGES TO BYLAWS

This is a sample bylaw with language struck out and new language added.

Example: Suppose you wanted to require that the State Central Committee's books be audited every year. Right now, we do it every four years. The current language is:

Article V 11. Budget And Audit Committee

2. Every four years, the budget & Audit Committee will order an independent audit of the State Party finances and present the findings of this audit to the State Central Committee.

So you might propose the following, and take the opportunity to fix a typo while you are at it:

Article V 11. Budget And Audit Committee

2. Every ~~four years~~year, the ~~the~~Budget ~~&~~and Audit Committee will order an independent audit of the State Party finances and present the findings of this audit to the State Central Committee.

PLATFORM PLANKS

A PLATFORM is a declaration of the principles on which our Party stands. Planks are statements of broad principles and timeless truths. The Platform planks are not something that change with the whim of a political moment.

The 2016 Wyoming Republican Party Convention approved a new, much shorter platform with no categories. There are currently nineteen (19) planks in the WY CCRP platform. You may propose to amend an existing plank.

Below is a sample platform plank with language struck out and new language added.

For example, suppose plank three is a bit awkward:

3. The right of individuals to keep and bear Arms shall not be infringed. Individuals must never be prevented from defending life, liberty or property if threatened unjustly.

We can re-arrange some of the wording:

3. The right of individuals to keep and bear Arms shall not be infringed. Individuals must never be unjustly prevented from defending life, liberty or property if threatened unjustly.

DELEGATE MEMBERSHIP and APPORTIONMENT

Delegates to the **County Convention** shall be the members of the County Central Committee (ninety-eight (98) precinct committeemen and committeewomen), and those chosen by the caucuses of the several precincts within Campbell County (one hundred (100)). All County Convention Delegates and Alternates shall at the time of the call for the Convention be residents of the precinct they represent and registered Republicans. (Art. IV 1.a.)

Each Precinct Caucus may also choose alternate Delegates equal in number to its allotted delegates and shall designate the priority in which the Alternates shall replace absent Delegates. (Art. IV 1.b.)

If Precinct Committeeman and Precinct Committeewomen vacancies exist at the time of the Caucus, the Caucus may elect Delegates equal in number to the vacancies. (Art. IV 1.c.)

The County Executive Committee is authorized to designate the total number of Delegates to be elected to the County Convention. The Delegates to which each precinct shall be entitled at the County Convention shall be determined, as nearly as possible, in proportion to the total votes cast in each precinct for the Republican candidate for the office of U.S. House of Representatives at the preceding general election. Each precinct shall be entitled to at least two (2) Delegates. (Art. IV 3.)
