1. Call to Order

CCRP Chairman Heather Herr called the meeting to order at 6:00 PM. Chairman Herr reiterated that the purpose of the CCRP is to get other Republicans engaged and the provide financial support to get Republicans elected.

6. Officer Reports

Chairman's Report

Chairman Heather Herr reported that she attended the State Central Committee meeting in Cody, Wyoming on May 14-15th. State Chairman Frank Eathorne asked Chairman Herr if Gillette would be interested in bidding on the next State Convention. He complimented Janet Mader on a job well done at the last State Convention. Chairman Herr advised there is a Right to Life Banquet on June 25th in Dubois. On June 22nd at City Brew, Chairman Herr will hold a "Chat with the Chair" open house as an outreach effort to engage more people in the Republican Party and answer questions that people may have about the party. The CCRP will have a booth at the Campbell County Fair and will need volunteers to man the booth. The Pink Elephant Ball is scheduled for March 26, 2022 and the Energy Hall at Cam-plex has been reserved. Fund raising efforts are underway and Chairman Herr encouraged all the members to get involved and bring people to our events.

State Committeeman's Report

There was training for new chairmen and committee members and a Zoom call with the RNC on fund raising training. On Saturday, Leland Christensen read a letter from Cynthia Lummis and Governor Gordon Spoke. The election of officers was held with Frank Eathorne re-elected as Chairman, Dave Holland re-elected as Vice Chair and Donna Rice elected as Secretary. There was a brief review of the March financials. The new district representative for Campbell County, Sheridan County and Johnson County is Kara Peterson of Buffalo with Carla Klopfenstein from Sheridan as the alternate.

Janet Mader offered a correction to Tom Lubnau's written report that Harriet Hageman was on the Election Integrity committee at the RNC.

Fund raising Committee Report

Co Chair Norine Kasperik said the committee has met once and the Co Chair Ronda Boller has been busy working on the Ice Cream Social event and is doing a great job. The first fundraising event is an Ice Cream Social with a Pie Auction on Sunday, August 15th, from 4pm to 6pm at the Inspiration Gardens at the Cemetery. Red Steagall, noted cowboy poet and musician, will be in attendance and the winner of the pie auction will get to share their pie with Mr Steagall. Local musician Kellen Smith will provide entertainment and the committee is working on auction items. Ticket prices have not been set yet, plans are to have the tickets available July 1st.

The Executive Committee will look at the bid documents and discuss it.
