Minutes

1. Call to Order

CCRP Chairman Heather Herr called the meeting to order at 6:00 PM. In her opening remarks, Chairman Herr welcomed the newly seated members and spoke to the role of the CCRP. “We will conduct business in accordance with the bylaws, we will uphold the platforms of the Republican Party and we will work to raise money to help get Republicans elected” stated Chairman Herr.

Chairman Herr spoke to the framework of resolutions. Resolutions are the mechanism that brings ideas to policy. The public can submit ideas to their precinct people, and they can also bring their ideas to the County Caucus, where the ideas are discussed and drafted into resolutions and then the resolutions are brought forth at the County Convention to be voted on by the party members. Resolutions are then submitted to the State Republican Party for consideration.

Chairman's Report

Chairman Heather Herr reported that her priority has been on a smooth transition and she wanted to thank the previous executive committee for their hard work and efforts on behalf of the Campbell County Republican Party.

Chairman Herr reported that additional committee assignments will be made when deemed necessary. The website and Facebook sites will be reviewed and upgraded and a policy for use is in the works.

The State Central Committee meeting will be held May 14-15th, 2021 in Cody, Wyoming. Election of officers will take place and State Chairman Frank Eathorne is seeking re-election. Chairman Herr, State Committeeman Tom Lubnau and State Committeewoman Heidi Gross plan to attend.

Vice Chairman's Report

Vice Chair Sam Clikeman gave a presentation on the history of the national Republican Party. Starting with the Kansas-Nebraska Act, the fight against slavery, through Manifest Destiny, Vice Chair Clikeman reminded us that the Republican Party was founded to advocate for free market labor, that we are in fact "freemen" with the inalienable rights to be who we want to be. Wyoming's first governor F.E. Warren, served several terms in United States Senate representing the Cowboy State. His daughter, Helen Warren married General John J. Pershing. Vice Chair Clikeman looks forward to making similar presentations throughout the year.

Treasurer's Report

Treasurer Toni Bell thanked past Treasurer John Howard for his service. Treasurer Bell reported that there is \$7,740 in our checking account. That included a \$555 donation made at the last Central Committee meeting. Moving forward, Treasurer Bell will create a written report to present at the meetings. She is working on constructing a budget report to aid the committee in planning for operational and fundraising needs.

State Committeeman's Report

State Committeeman Tom Lubnau and State Committeewoman Heidi Gross will take turns making reports at the Central Committee meetings. State Committeeman Lubnau

reviewed the WRP financial report, informed the CCRP that the WRP is involved in a lawsuit with the Natrona County GOP concerning the State Party Convention and about pending litigation with the Unita County Republican Party concerning its election of officers. Raffles are illegal but beginning July 1st, 2021 they will be legal for fundraising for political parties.

The CCRP bylaws provide for resolutions to be brought forth at County Caucus and voted on at County Convention and then sent on to the State Convention. Changing the process would necessitate a change in the bylaws which can only be done at the County Convention. It was suggested to consider creating a Resolution Committee, whereby ideas could be organized to be brought forth to the county caucus. Chairman Herr stressed that every citizen already has the inherent right to go to their elected officials and give them their opinion. It is not the role of the CCRP to tell the elected officials what to do and nobody is being kept from saying whatever they want to the elected officials.
